RESOLUTION NO. 33-22

AMENDING BONNEAUVILLE BOROUGH CODE OF ORDINANCE CHAPTERS 242, SECTION 242-7(a)(1), RELATING TO WATER RATES CHARGED AND CHAPTER 184, SECTION 184-22(C) RELATING TO SEWER RENTALS AND CHARGES

WHEREAS, pursuant to the Bonneauville Borough Code of Ordinances Chapters 242, Section 242-14 as well as Chapter 184, Section 184-30, Bonneauville Borough Council ("Council") has reserved the right to adopt, from time to time, such additional rules and regulations as it shall deem necessary and proper in connection with the operation of the water system and the sewer system respectfully; and

WHEREAS, Council desires to amend Section 242-7(A)(1) relating to water rates charged for usage over 5,000 gallons per billing period as well as amending Section 184-22(c)(2) which relates to sewer system usage over 5,000 gallons per billing period.

NOW THEREFORE, BE IT RESOLVED that Council amends Section 242-7(A)(1) and Section 184-22(c)(2) as follows:

"Section 247-7 (A)(1)

(1) Schedule of meter rates

(a) All metered billing units shall pay a consumption charge, per month, for consumption of water as follows:

MONTHLY WATER VOLUME USAGE

For first 5,000 gallons

All over 5,000 gallons

MONTHLY RATE

\$27.41 per 5,000 gallons or fractional part thereof

\$2.10 per 1,000 gallons or fractural part thereof

(b) Notwithstanding the foregoing, the minimum water usage charge shall be \$27.41 per month for each billing unit."

"Section 184-22(C)

Sewer rentals and charges imposed by Subsection A and B shall be computed in accordance with the following rate schedule, subject however;

- (1) To the minimum sewer rentals or charges provided in this Subsection C; and
- (2) To the provisions, if applicable of Subsection H:

MONTHLY WATER VOLUME USAGE OR
METERED WASTE DISCHARGED

MONTHLY RATE

First 5,000 gallons

\$67.59 per 5,000
gallons of fractural
part thereof

All over 5,000 gallons

\$8.90 per 1,000
gallons or fractural
part thereof

(3) Notwithstanding the foregoing, the minimum sewer rentals or charges shall be \$67.59 per month."


The aforesated amendments shall become effective the first billing period commencing in January 2023.
